INSTRUCTIONS:

- -Include these services in your quote: Proper personnel to remain on-site for the duration of the event to replenish food and beverages, and to maintain a clean serving area. Provide black linens for tables from which you will serve food, beverages, and desserts. Provide in advance the number of tables you will need set up for this purpose.

Also, at conclusion of event, cleanup of the food serving area and removal of any debris or trash, and personnel to assist and help in clearing guest tables of dishes. Tablecloths on guest tables are the property of the City of Seneca, and you are not expected to remove those. You will not be expected to perform any cleanup other than what is listed here.
- -Provide clear disposable dinnerware to include dinner plates, flatware, cups, dessert plates and an adequate number of to-go plates for all attendees. Food left over at the end of the evening is to be offered to guests to take home with them. This is a tradition with the City of Seneca.
- -Provide menu board at entrance to serving area.
- -You may structure your quote in this manner: Your primary quote should be based strictly on the menu items as requested below. No substitutions and no unexpected additions. If you wish to offer alternate creative menu ideas, you may list those ideas as options. For example: Primary Quote, Alternate Quote 1, Alternate Quote 2, Alternate Quote 3, etc. *Important: Please indicate how your suggested options will monetarily affect the price per head.*

References and/or taste testing may be requested before final award indicating the ability of the caterer to handle events of this size. If your company has done previous work for the City of Seneca, please indicate that in your proposal. Other factors that will be considered in awarding bid are: food quality, taste and presentation; professionalism and service; cost and value for money; ability handle large events.
